Alabama HB123 (NO opt in required for those 14 and up along with NO PARENTAL PERMISSION required for SERVICES.) Each local board of education shall:

- 1. Complete, and submit to the Alabama Department of Mental Health, a needs assessment and resource map for the schools**
- 2. Shall document the status of mental health for the entire school system**
- 3. Engage in a quality improvement process to improve the provision of mental health resources to students within the school system.**

"For the purposes of this section, "mental health services" includes SERVICES, TREATMENT, SURVEYS, or ASSESSMENTS relating to mental health"

NOTE: "President's FY23 budget proposes over \$27 billion in discretionary funding and another \$100 billion in mandatory funding over 10 years to implement his national mental health strategy." Biden's Unity Agenda

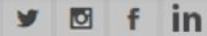

In other words, if voters agree to this, Cleveland sounds the alarm, it will "guarantee" that the state lawmakers "cannot interfere in transgender minors' decision to obtain puberty blockers or surgical 'gender reassignment' through castration, removal of ovaries, or a hysterectomy." As Section 4 makes quite clear, the state will go to great lengths to protect "an individual's autonomous decision-making"—even if that individual is under 18.

"Children will have a right under the Michigan constitution to walk into one of Planned Parenthood's 12 so-called 'gender-affirming' facilities in the state and, without parental knowledge or consent, obtain puberty blockers," Cleveland writes. And thanks to the rise of telemed, it won't be long until they don't even have to leave the house to get their hands on a whole array of life-altering drugs.

At the end of the day, Cleveland insists, "Prop 3 isn't about codifying Roe. It's about sacrificing the children of Michigan—both born and unborn."
